- Deposit money will secure Buyer's puppy until it has been weaned, received a health certificate from Seller's vet, and received initial vaccinations and de-worming
 - Deposit funds are non-refundable unless no puppy is available as planned, in which case Buyer shall receive full refund from Seller upon request.
 - Buyer shall have chosen puppy at 6 weeks of age or at Seller's discretion.
 - Seller, the owner of litter, reserves the right to refuse or dispute any decision until puppy is paid in full.
 - Buyer assumes full ownership for puppy at the time of exchange, and therefore the
- Seller is not liable for loss, theft, or accident once ownership is transferred.
 - Within one (1) week of transfer, Buyer must register puppy with the AKC and enroll/upload microchip info.
 - Buyer must have puppy examined by a licensed vet within ten (10) days of receipt of sale and send Seller a copy of the veterinarian's receipt. Failure to send veterinarian's receipt to the breeder within ten (10) days of exam will render this guarantee completely void.
 - Buyer shall not vaccinate puppy within seven (7) days of receipt.
 - Breeder will have administered initial
- vaccination and booster. Buyer shall quarantine puppy until third dose of vaccine has been administered.
 - Puppies are sold as pets and shall be spayed or neutered after six months of age, or as recommended by a veterinarian. Buyer is responsible for all fees related to the spay/neuter surgery.
 - Buyer is responsible for daily health care and maintenance of puppy. Buyer shall provide quality food, supplements, water, shelter, exercise, sanitation, love, discipline, and regular vet care.
 - In the event Buyer cannot keep puppy for any reason, Seller shall be given the opportunity to readopt.

TWO YEAR HEALTH GUARANTEE

No guarantee is made as to disposition, confirmation, size, weight, color, markings, or lifespan. Seller does not guarantee against low blood sugar, internal/external parasites or any other non-life threatening illnesses common to puppies after leaving Seller. In case of severe knee elbow or hip dysplasia, congenital or genetic/hereditary defects that adversely affect the health of the puppy, or in the unlikely event of death due to genetics within two (2) years from its birth, the Seller shall replace the pet with another of equivalent value (within 18 months) at no cost to the buyer (excluding shipping, travel and transport costs) or issue a credit in the amount of 50% of the original cost of puppy. This decision is at the discretion of the breeder. Seller must be notified within two (2) days of licensed vet's determination of severe condition as mentioned above. A statement from two (2) licensed DVMs of buyer's choosing is required before any action shall be taken. Seller reserves the right to a third opinion of Seller's choosing. If the buyer declines the aforementioned conditions then the Seller shall be under no further obligation, and it will be deemed that the buyer has released the Seller from any and all further claims. If the buyer must return the puppy for any reason other than severe health conditions mentioned above, it will be on a surrender basis only, with no refund or credit from the Seller. This guarantee is non-transferable. In the event this guarantee is exercised, the registration papers must be returned to the Seller and all veterinarian and dog food/supplement receipts must be provided at the Seller's request.
